ABSTRACT

Cricket is the most sensational and renowned sport in the world. Betting is the dark side which darkens the true spirit of this sport. The standard of the point, investigated the financial effect of betting of young cricket players and identify the noteworthiness for the cricketer's inclusion in wagering. It examines the attribute of betting and the role of the bookie in cricket betting. Wagering could be a limit key by various players all throughout the world. Betting in cricket prove itself to be the smart way of richness in a short period of time. Literature revealed that Pakistan super league and Indain prime league is a turning point when businessmen invest in the matches. It turned into a match fixing and hub of betting. This leads bookie's attention towards local grounds and they attract local players towards betting. This study draws the investigated that the betting is no longer the physical activity it can be played at anytime and anywhere. This thesis also breaks the myth of having crowed to perform betting. There is no cricketer based investigation of betting among young players in Pakistan. This study proves concentrate local and cricket club player's commitment in bet practice and the majority causes of betting. Rational choice theory illustrates this scenario well as people attracted towards it by their own choice. They achieve their goals through short way and end up earning profit which is their basic need. The theatrical framework investigated the betting in cricket matches are being fixed for their collective and personal need or motivations, where players are themselves involved to act such behavior. In this process sometimes the individual lose is considered the collective win. Players in cricket match are involved in betting due to internal and external pressures. The social pressure and money linked conditions causing bookmaking the internal pressure included the personal motivation and behavior towards the certain act or the action. This finding is extracted from in-depth interviews of qualitative

approach. Sample size is 15, 10 in-depth interviews were taken from cricket players and 5 in-depth interviews were taken from bookies. Sample was purposive sampling selected from some cities of Punjab and capital city Islamabad. Data was collected and sfter coding it analyzed through software of Nvivo. The result rejected the myth of less gambling in open small grounds. It is hidden but findings extracted is to break the myth that the crowd has a role in gambling in one or another way. The second strange finding is to reveal the chain of gambling that starts from street persons and ends at the heavy party by linking the agents and players. The third distinctive finding is to find the way of transferring of assets by "Hawala Hundai" method.

The fourth unique finding is to illustrate that the gambling scale at low level local tournaments is far bigger than the national and international tournaments.

The findings from this study provide an important starting point for more comprehensive investigations about the impact and influence of betting on young cricketers and society. This study suggests that there is no single factor that propels young cricketers to perform betting. Betting is not only affecting the young cricketers physically and mentally but also has devastating effects on society as it is against our social norms. Betting cannot be completely eradicated but can be minimized by applying different strategies at a different level. Higher authorities and guardians of local young cricketers have responsibilities to save their talents through proper guidance and counseling. This study proves focus on local and cricket club player's bond in batting practice and the predominance causes of betting. Many factors together lead the players towards betting and bookies play important role in it.

Therefore, most Internet gambling sites are located overseas.

However, online gambling seems to be a very profitable market, with several government agencies actively participating, the Netherlands, New Zealand, Australia. It has grown into a multi-million-dollar company with more than four hundred active websites on the Internet suggested that the motivation, attitude, and behavior of young people who watch or participate in sports such as American Football League, cricket, football, horse racing place a bet on sports (Armstrong, Anna, and Max 2018). Young people who say they gamble every week or more are more likely to spend more money on other sports, use multiple online gambling accounts, and are driven by boredom and lossall of which are warning signs (Bestman, Samantha, Melanie, and Stuart 2015). Today, children and adolescents in North America remain the first-generation of teenagers who have grown up in a community in which there are several kinds of betting spots not only are the most common but also widely promoted and promoted. Along with sin and sin, it is now generally be regarded as safe mature entertainment as well as has transformed in most of our community. Even Though gambling is governed by the Canadian government is prohibited for teenagers beneath the age of eighteen, this number is rising teen age year-olds have extremely significant bookmaking troubles, an additional risk of emerging betting difficulties. Young people play for fun and entertainment (Derevensky and Rina 2004).

The gambling sites remain unregulated. In fact, for young people who often go online, this can become a problematic marketing strategy, such as pop-up ads that encourage gamblers to visit adult gambling sites. However, progressively more young people are beginning to access the internet. For example, throughout Canada, information gathered by five thousand youngsters between the ages of nine to seventeen years show that ninety percent of people said they use the Internet at least partially, and they can access the Internet at home. High school students use the Internet to play download games, elementary school students do the same. Teens old have a computer in the house, and they play games through the internet at least a couple of times a week (Willms and Corbett 2021).

The difference in prevalence can be partially explained by the increase in Internet access in public places. In a survey conducted by the Western Canada Foundation, the most common reason for quitting online gambling was the inability to access the Internet, while young people were more likely to gamble online (Ladd and Nancy 2002).

However, young people want to try online gambling. Compared with young people in the United States, recent Canadian data demonstrate that no less than twenty-five percent of teen persons by major problem gambling and twenty percentage of young people on the danger of gambling problems determined by the number of exclusion criteria can play online (Hardoon, Jeffrey and Gupta 2002).

Of course, this is a serious negative consequence yet, in certain cases it is true. There are many risk factors associated with adolescent addiction to betting, including parents with gambling problems, the age at which point they started gambling earlier, and increased impulsivity. Children of problem gamblers usually start playing games earlier than their peers. The premature gaming age is particularly worrying because it is reported that the premature gaming age is related to several negative performance indicators. These poorly functioning areas include not only young people's gambling problems, but also health, mental illness, and drug problems family social issues at a young age. However, the nature of these associations is still incomplete, because a large amount of data has been obtained from cross-sectional and/or retrospective studies, and there are relatively few related longitudinal studies (Griffiths and Richard 2000).

As an emerging and evolving topic of young people's online games, due to its isolation and insufficient supervision, in a relatively short time. In addition, many young people are familiar with computers, which raises additional concerns that they may be more Mostly involve in computer games more than adult peers. There are technical difficulties in the regulation of online gambling. Because some countries allow activities and other countries restrict such as the United States and people can access international websites, it belongs to the world of the Internet. Sexual difficulties in monitoring general online gambling. These difficulties extend to young people. For example, many teenagers with serious gambling problems report using websites dedicated to gambling. The federal trade commission has already warned children issue and online gambling. In his research, he found that minors can easily access gambling websites, minors cannot see or do not have gambling warnings, and young people encounter gambling website advertisements on other websites (Ernst, Daniel and Michael 2006).

Gambling among young people is a growing public health problem. Although gambling is generally regarded as a harmless pastime for adults, minors, both regulated and unregulated forms of gambling, are largely tempted and pressured to achieve this. Such adult, research suggests that young people's gambling problems can have negative effects, such as relationship pressure, crime, and criminal behavior, including depression. Such negative consequences have both short-term and long-term effects on people. Other important and the whole society (Jacobs 2000).

Gambling has become a popular pastime for young people. Although the law generally prohibits young people from engaging in legal shapes of wagering, there is little doubt that they could participate in both lawful and unlawful shapes that are of gambling. Throughout his life in one way or another. However, the most worrying thing is that there is evidence is that teenagers have a serious wagering problem, and another ten to five percent of teenagers are in danger of drugs (Collins and Barr 2001).

Although there are some methodological problems in measuring pathological gambling among the young, it has been indicated that the prevalence of compulsive gambling among teenagers is higher than that of normal young people. The trend shows that the proportion of young people reporting gambling and the proportion of young people reporting gambling problems have increased significantly in the past year. It is estimated that in the United States and Canada many teenagers are involved in gambling and drugs through different aspects. Although most young people consider gambling is related to cash, the temptation of gambling, fun and the economic freedom brought about by betting and gaming is especially appealing to young people. Especially susceptible to the dangers and negative implications of bookmaking (Derevensky, Rina and Ken 2003).

Cricket has the second-most fashionable game later soccer. The country's most successful cricket league is the Indian Premier League. Cricket is the most popular sport with a large population and is regarded by fans as their religion. Pakistan will have the same fondness for cricket. This is an important comparison factor between the two leagues (Wardle et al 2011).

Indian premier league is considered to be one of the richest in the world leagues in sports, not just cricket, it is preferable and so much more delightful than Pakistan super league. The assessed brand name worth of the Pakistan super league is nearly a million dollars. Audiences and supporters are also important factors in the success of PSL and IPL. The Indian League has a large audience, while the Pakistan super league is being held in Dubai, therefore the crowd is small, although the stadium may be crowded. When it happened in Pakistan (Wood and Robert 2011).

Pakistan Super League (PSL) is measured by profit, so franchisees might lose some money, but they will be able to see the future possibilities through investing in this big game. Compared with Western countries, Pakistan's sports leagues require very little investment. The investors can buy complete franchises for less than the amount that players exchange in football leagues the industry is booming in the region (Killick and Mark 2019).

Pakistan super league (PSL) and Indian prime league (IPL) face the biggest challenges that could be solved or else cut by the government, plus income tax relief, fraud humiliations, and the political impact because the Indian league faces huge capital and profit problems caused by organizing expensive activities. According to the sports news website ESPN Cricinfo, the UAE venues, therefore, did not make a lot of money in overseas stadiums. PSL lost million US dollars per person for the first two series, while at the same time their respective owners have attempted to restructure a league, and the struggle for tax relief to achieve this agreement is more cost-effective (Lopez-Gonzalez, Ana, and Mark 2019).

Politicians use this big game to produce money for the reason that bribery is the biggest issue in India and Pakistan. Even if these teams are privately owned, the cricket committee will run these leagues. This means that the minister of sports and the chairman of the Indian cricket board are appointed by the department of sports or staff. Therefore, politicians can attribute political influence to anyone, so favoritism and nepotism are well-known mistakes made by politicians. Various situations, such as spot-fixing and the profound lobbying of cricket forms, and at the very least in India, have also turned into a commonplace (Shaffer et al 2010).

Indian Premium League (IPL) must supervise the match schedule of the event. A few years ago, multiple match-fixing scandals made headlines. Some of the biggest cricket scandals in India and Pakistan are Pakistani players' match-fixing scandal against Pakistan Super League (PSL), in which some players were found guilty of one-time criminal instances in England, and the semi-finals among Pakistan and India were reported in 2011. The cricket world cup for the year has been confirmed. There may be four Pakistani players who are not efficient enough to fight for money (Pandit 2011).

Cricket gambling is illegal in most countries, but gambling is legal in five countries Australia, Britain, the Republic of South Africa, Srilanka, and New Zealand. Although the business is growing on a large scale and cannot be fully controlled by the authorities, it is still illegal in India (Xuan and Howard 2009).

Gambling sites have developed into a various-trillion dollars manufacturing sector, although there are still prohibited activities in the subcontinent, however, with the rising of these trillion bets, some countries have legalized it. Gambling is likely to be legalized in India soon because gambling and gambling will become huge soon and cannot be controlled by the authorities. Growth is to be supported by stakeholders and IPL franchise owners (LaPlante, Anja, Richard, and Howard 2008).

Gambling may be allowed in Pakistan for the reason that it is an Islamic Republic country. The country must abide by religious rules and laws based on religion. However, despite strict laws prohibiting gambling, the gambling mafia was found to have million dollars profitable. Pakistanis betting on cricket most of the citizens use some betting places and come into contact with the gambling circle whom they bet on cricket matches. Cricket officials are mainly concerned with betting and match odds, which indirectly affect the match and the young players. Reason For This is these gangs an attempt to provide the payoffs to players to bargain with for match. Eleven gaming companies were also arrested in a night raid all over India (Swartz, Paramjit, and Saman 2009).

The Cricket World Cup is the largest cricket tournament in the world, with teams from all over the world participating in the 2011 World

Championships were held in India, Sri Lanka, and Bangladesh. Then the number of bets during the Indian Primier League (IPL) in the same year is also very enlightening. India's huge gambling industry is no longer a secret. Despite numerous arrests and police raids in other countries and India, the gambling company is still operating. There are also known cases of Indian police calling from the office of a gaming company (Batool 2019).

In 2010, before the establishment of the Pakistan Super League, a major match-fixing scandal turned into a major media incident, when a British newspaper disclosed that three Pakistani players were suspected of receiving kickbacks from gaming companies. Test The British Newspaper News of the World released a video in which the betting company offered Pakistani bowlers million dollars to pitch without the ball on a certain match day (Sharp et al 2011).

The newspaper published pictures of casinos and table wallets. The newspaper named three players involved in the scandal: Salman Bart, Mohamed Asif, and Mohamed Amir, all of whom were suspended by the International Cricket Committee. The period is five to ten years, depending on your participation (Lemmer 2013).

Pakistan Super League is a new company there have been no major match-fixing scandals or witnesses to gambling so far, but despite strict laws and fines, this illegal business is no longer a secret. When several players have been investigated through the fight against the corruption department of the Pakistan cricket committee and were suspected of participating in match-fixing, they were barred from entering the Pakistan Cricket Board (PCB). There appeared to be a match-fixing scandal. The investigation was supported by the following organizations' anti-corruption agency of international interest Rates. In 2017, the Pakistan cricket team suspended or suspended six players a few trustworthy informers also reported that Shajir and Khalid Latif, the players that played for the Islamabad united champions team had been only caught because of contact with bookmakers. Indian Premier League is illegal, but it is still used in many ways, manipulating players, and taking professional risks for money. Officials and state governments in India and Pakistan failed to control gambling. However, in India, the Indian commission for the legalization of cricket gambling put forward a proposal to legalize gambling, but it caused a mixed response from the public. This has not been greeted by cricket supporters and the public in general, however the interested parties and legal specialists who support the preface and support of gambling (Malcolm, Jon, and Nalin 2009).

Although these

characteristics are common to all online sports betting players, little is known about the specific betting behaviors common to those whom to do only available from selected online providers. These studies show that betting odds are generally moderate, and players adjust their betting frequency, the number of bets, and the betting scale based on winning or losing. CHAPTER NO 3 THEORETICAL FRAMEWORK


3.1 Rational Choice Theory



CHAPTER NO 4 CONCEPTUALIZATION AND OPERATIONALIZATION


4.1 Betting


5.6 Technique for Data Collection

The big tournaments are golden opportunities for fixer players and bookies to get rewards. The bookies organize and watch over the tournaments properly with full care and consciousness. All the data were collected from more than ten respondents with an age limit of 22 years to 34 years. Out of all respondents, almost two-third provide a piece of reasonable information for research work.



6.2 Illusion of Money and Popularity
